TERMS & CONDITIONS:

- 1. The Director, CFSPF Bangalore reserves the right to reject any or all quotations in whole or inpart without assigning any reason therefore. The decision of Director. CFSPF bangalore shall be final and binding on the Agency in respect of clause covered under the contract.
